1. The Promoter

2. Eligibility

2.3 One entry per business. Duplicate entries from the same business will be discounted, and only the first valid entry will be counted.

2.4 No purchase is necessary. Entry is free.

3. How to enter

3.1 Enter by completing the entry form at socialgrowthsystems.co.uk/free-audit/, giving your name, business name, email address and a link to your social media profile.

3.2 Entries must be received by the closing date for the relevant draw (see section 4). Entries received after the closing date are automatically carried into the next monthly draw.

3.3 Entries that are incomplete, illegible or that the Promoter reasonably believes to be fraudulent will be rejected.

3.4 The Promoter accepts no responsibility for entries that are not received due to technical failure, or for any other reason outside the Promoter's control.
